Statistics fields import (Hospital Statistic.txt) in SwissSalary (SaaS Cloud):

“Settings – Employee statistics – Actions – Interface – Import” --> Import file

For onPrem or SwissSalaryNAV solutions:

“SwissSalary management – Employee statistics – Interface – Import --> Import file”

The fields and subtables for the statistics/group HOSPITAL-1 to HOSPITAL-5 are imported.

Note | HOSPITAL-4 statistics/group

*If the statistics fields of the **HOSPITAL-4 statistics/group** are not yet available in SwissSalary, the main location(s) must be entered/stored manually in the group under “Settings – Employee statistics – Actions – Group”.*

Evaluation

Initial setup for onPrem or SwissSalary NAV solutions:

“General reports – Edit – New” --> Report ID: select Object ID 3009320 (remaining fields are recorded/supplemented automatically)

3 Evaluation in SwissSalary

3.1 Preparation

The statistics fields are assigned to employees under "Employee – Employee statistics – Edit list – – Group" Assign the desired attributes as per FSO specifications.

Employees for Hospital statistics

- Hospital statistics | Origin of the diploma
- Hospital statistics | Main service location
- Hospital statistics | Role --> Enter the GLN No. into the Comment column **)
- Hospital statistics | Main location

***) The Global Location Number (GLN) is only to be recorded for doctors and midwives (roles 1 - 5, 12, 33, 34).

Employees, NOT in Hospital statistics

- Hospital statistics | Not in Hospital statistics --> for employees who are to be excluded from the statistics, the "YES" option must be explicitly selected here

Note | Variable A.14.09 - Personnel in training

Output value is determined from the personnel card under Statistics - Employment contract:

- Apprenticeship contract = 1
- other contracts = 2

Note | external personnel

Statistical data for external personnel can only be submitted if they are also managed in SwissSalary AND time recording is available (A14.05.04 Hours worked per year).

3.2 Creating evaluation

The report can be retrieved directly in SwissSalary (SaaS Cloud) via "Search" (magnifying glass) – "Hospital Statistics 5.4.0.4".

For onPrem or SwissSalary NAV go to: "General Reports – Hospital Statistics 5.4.0.4"

Notes

- The Company number (= BUR No.) of the healthcare organization is taken from Payroll Setup "General/Headquarter/BUR No."
- The workload is calculated using the base wage and the overtime paid for.

4 Adjustments in the Employee statistics

In the event of adjustments to this statistics area in the future, the updated file can be re-imported. The statistics fields will be adjusted based on the new file.

ATTENTION: **Do not delete** the existing statistics beforehand, otherwise the statistical data associated with employees will be deleted and will have to be reassociated.
